Summary

The Gold Heart Challenge Cup is hosted by The Heart of America Chapter (HOA) of USAVB. This is a two day tournament. There will be six pools of four teams. Five pools will play at the HOA facility in KCK and one pool will play at the Parkville Athletic Complex in Parkville, MO. This is a Gold tournament which means that it is open to Gold and Silver teams – provided that at least two gold-level teams are entered in each pool in the proper age division. Warm-up begins at 7:45a.m. Coaches meeting will be at 7:30 a.m. The first round of pool play begins at 8:00 a.m. with a 2-4-4 warm-up. Warm-ups will be 1-3-3 after 1st and 2nd round of play.

Tournament Play

First round, six pools of four teams. Five pools will play at the HOA facility, one pool will be played at the Parkville Athletic Complex. Distance between the 2 facilities is 11 miles. Some teams will be changing locations between rounds.

All pool matches will be 2 21-point sets. All playoff matches will be best 2 of 3 sets.

The teams will be ranked for Bracket play accordingly to the following:

1. Win-loss record.
2. Head to head competition.
3. Point differential between tied teams.
4. Point differential in all games.
5. If a tie still exists then a 15 point tie breaker game will be played to determine team to advance to tournament play.

Driving Directions

From I-70: Take the 7th Street exit and go South one block to Kansas Avenue. Turn West on Kansas Avenue. Go one block and turn right onto Coy Street. Right before the HOA facility, turn left onto the access road to the parking lot. Main entrance and parking lot are on the West side of the building. **DO NOT PARK IN THE GROCERY STORE PARKING LOT SOUTH OF THE BUILDING.**

6014 N. 9 Highway, Parkville, Missouri. Take I-70 to Rt 169. Go North on 169 over the Broadway bridge by the downtown airport to Hwy 9. Follow Hwy 9 through Parkville. After sharp right turn, PAC is about 3/4 mile on the left hand side.
