Summary

The Silver Heart Challenge Cup Volleyball Tournament is a two day tournament sponsored by HOA. Matches will be played at the Q-Courts and Levo Gym on Saturday & Sunday, February 20-21st. There will be seven (7) pools of four teams each. This is a Silver tournament which means that it is open to Silver and Bronze teams only. All teams will play on Saturday, re-pool on Sunday morning and complete the pool play before starting bracket play on Sunday afternoon. Warm-ups begin at 7:45a.m. each day. Coaches meetings will be at 7:30 a.m. The first round of pool play begins at 8:00 a.m. with a 2-4-4 warm-up. Warm-ups will be 1-3-3 after 1st and 2nd round of play.

Tournament Play

Tournament play will be divided into Pool Play (morning) and Bracket Play (afternoon). Pool play will consist of two games to 25 points, win by two with no cap, rally scoring, starting with 4-4 on the scoreboard. The top 4 teams from each pool advance to Tournament (bracket) play. The teams will be ranked for Bracket play accordingly to the following:

1. Win-loss record.
2. Head to head competition.
3. Point differential between tied teams.
4. Point differential in all games.
5. If a tie still exists then a 15 point tie breaker game will be played to determine team to advance to tournament play.

Bracket Play

Bracket games are single-elimination, 2 out of 3 games to 25 points, rally scoring, win by two points with no cap. Medals will be presented to the first and second place teams in each age division. During Playoffs the losing team is required to officiate the following match.
